## Washington Professional Fee Schedule Mid-level Practitioner Update

Effective March 1, 2013

Premera Blue Cross is implementing an update to the March 1, 2012, News Brief, "Washington Professional Fee Schedule Update." Premera will reimburse mid-level practitioner professional services at 85% of the medical fee schedule effective for dates of service starting March 1, 2013. This change will align Premera with how the industry and Medicare reimburse for these practitioners. This update applies to claims for all Premera companies and commercial products.

*Impacted practitioners include Nurse Practitioners, Physician Assistants and Advanced Registered Nurse Practitioners who perform services in settings other than those listed on the reverse side of this News Brief. Effective March 1, 2013, all impacted practitioners must:*

- Bill for services under his/her own name.
- Complete the credentialing process as part of our ongoing commitment to quality – not applicable to delegated credentialed groups. Credentialed providers will be advertised in Premera's online "Find a Doctor" directory (as applicable). Please read the following information before proceeding any further:
  - ProviderSource is Premera's preferred method of receiving credentialing information.
