

Alaska Dental/Vision/Hearing Plan

1-Year Term or 3-Year Term

For coverage starting January 1, 2017 or later

Premera Blue Cross Blue Shield of Alaska offers a Dental/Vision/Hearing Plan. A description of benefit coverage is as follows:

Vision Benefit Highlights

Benefits are limited to a \$350 benefit maximum per benefit year.

Your plan provides benefits for covered services when provided by a vision specialist such as an ophthalmologist, optometrist, or optician. You are responsible for any charges over the allowed amount and charges that exceed the benefit maximum.

Covered services include:

- One eye exam, including a refraction, during a benefit year. This plan covers 90 percent of the allowed charges for the covered exam.
- Lenses, but not more than 2 during a benefit year.
- Frames, but not more than 1 pair every 2 benefit years.
- Contact lenses that are needed because of cataract surgery or when extreme visual problems cannot be corrected to at least 20/70 with glasses. Benefits are limited to 1 pair.
- Contacts in lieu of glasses, but not more than \$170 per benefit year. These will be covered the same as any other single-vision glasses.



Hearing Benefit Highlights

Your plan pays 80 percent of the allowed amount up to a maximum benefit of \$800 during a single contract term. You are responsible for the remaining 20 percent and any charges over the allowed charge amount and/or over the \$800 maximum.

Covered services include:

- An otological (ear) examination by a physician or surgeon.
- An audiological (hearing) exam and evaluation by a certified or licensed audiologist, including follow-up consultation.
- A hearing aid (monaural or binaural) prescribed as a result of an exam. This includes ear mold(s), hearing aid instrument, initial batteries, cords, and other necessary supplementary equipment as well as warranty, and follow-up consultation within 30 days following delivery of the hearing aid.
- Repairs, servicing, or alteration of hearing aid equipment.

The maximum benefit for each person is \$800 per contract term. You must provide Premera with written certification from the examining doctor, explaining a hearing loss exists and that the hearing loss may be reduced by the use of a hearing aid.

Ten-day right to return

Please read your contract as soon as you receive it. If you are not satisfied for any reason, you may return the contract within 10 days after you receive it. Any subscription charges paid will be refunded. The contract will then be void and not considered effective.

Eligibility, Enrollment, and Payment

Any Alaska resident may enroll in the Dental/Vision/Hearing plan. There is no health statement to complete and you cannot be declined as long as you are an Alaska resident at the time you enroll. When applying, you can choose either a 3-year or a 1-year (annual) contract. The full subscription charge must be paid at the time of application, and once coverage starts, the payment is non-refundable.

Each family member applying for coverage must complete their own application, calculate their subscription charge either on the 3-year rate contract term or the 1-year rate contract term using the rate table above, and return the application(s) along with payment in the envelope provided. Coverage will begin on the date specified on your application. If there is no date indicated, coverage will begin on the first day of the month following receipt and acceptance by Premera. When the contract is about to expire, you will be notified and you can reapply at that time. You can reapply as often as you wish, with an unlimited number of back-to-back contract terms. The current contract must have expired before a new one can begin.

The state of Alaska requires that all Alaska subscribers are informed of the availability of the Dental/Vision/Hearing plans.

This is only a brief outline of the benefits provided by this plan. It is not a contract and does not include all of the benefit limitations or the exclusion provisions. The complete terms of the coverage will be determined by the contract.
