Rates effective April 1, 2023

We can only change your subscription charges if we change them for all plans like yours in this state. In each year, we base your subscription charges on your age on April 1. For instance, if you are already age 70 on April 1, 2023, we will charge you the rate for members who are age 70. If, on April 1, 2023, you have not turned 70 yet, we will charge you the rate for members who are age 69.

You get a discount of \$5 per month if you enroll in our Automatic Funds Transfer (AFT) program.
