Premera Blue Cross Blue Shield of Alaska is committed to simplifying your experience when it comes to FSAs and other personal funding accounts. We aim to make it easy to manage your healthcare costs so you can save time and be reimbursed faster.

What is an FSA?

A Flexible Spending Account (FSA) is a tax-advantaged account that allows you to use pre-tax dollars to pay for out-of-pocket qualified medical or dependent care expenses. You choose how much money you want to contribute to an FSA at the beginning of each plan year and can access these funds throughout the year.

Benefits of an FSA

The main benefit from using an FSA is you do not pay taxes on the money you put into your account. So you can reduce your taxable income by the amount you contribute to your FSA, which means you save money.

Other benefits of using an FSA include:

Easy way to pay for healthcare expenses—Use your healthcare payment card to pay for eligible expenses at approved merchants and providers that accept debit cards.

Wide list of eligible expenses for your FSA funds—Eligible expenses incurred by you, your spouse or eligible dependent may include medical, dental and vision care costs, copays, coinsurance, prescriptions and some over-the-counter medications.

Rapid reimbursements—If you pay using a method other than your healthcare payment card, you can quickly create your claim online. Once you submit your receipts, you will be reimbursed by check or direct deposit.

Automatic savings—The amount you budget for healthcare expenses is automatically withheld over pay periods throughout the plan year.

Two FSA Types

Healthcare FSA

A healthcare FSA can cover medical, dental or vision expenses that you would otherwise pay for out of pocket. Common qualified expenses covered by a healthcare FSA may include:

- Health plan deductibles, coinsurance or copayments
- Vision care services
- Dental care services
- Hospital charges
- Laboratory fees
- Prescriptions and certain over-the-counter items

Your employer may limit the expenses your plan reimburses. Please contact your Human Resources office for more information.

Dependent Care FSA

Your employer may also choose to offer a dependent care FSA, which covers dependent care expenses that allow you and your spouse to be employed.

With a dependent care FSA, you pay for these expenses and get a tax break at the same time. Typical expenses under this account include:

- Charges for day care
- Pre-school
- Elder care (unless it is for medical care)

Expenses must be for dependents under the age of 13, or physically or mentally incapable of caring for themselves.

Contributing to Your FSA

Some good things to know about contributing to your FSA include:

Contribution Limits—You cannot contribute more than your employer or the IRS allows for healthcare and dependent care accounts, respectively.

Unused Funds—You may have the option to roll over up to \$500 of unused funds at the end of the plan year. However, please check with your employer first, about the selection they have chosen, to see if the roll over option is available to you.

Using Your FSA

Access your FSA to pay for eligible healthcare expenses easily:

Use your healthcare payment card—Present your card for qualified purchases at approved merchants or providers.

Use another form of payment and request reimbursement—Pay with your own credit card, cash or check, then log in to your online account and file for reimbursement. You can receive your reimbursement by check or direct deposit.

Keep your itemized receipts as documentation—You may be asked to submit receipts for some purchases.



Using Your Online Account

Find out all you need to know about your account anytime by going online. Log in at **premera.com**. Click on *Personal Funding Account*, then on **Manage Your Account** to:

- Check your account balance
- View healthcare payment card charges
- Enter a new claim
- View the status of claims
- Learn when you need to submit a receipts

Set up Direct Deposit

1. Log in at premera.com. Click on Personal Funding Account, then on Manage Your Account. Next, select Direct Deposit under My Account.
2. Complete the short, secure form. Be sure to have your bank account and routing numbers on hand.
3. Choose Direct Deposit as your preferred method of Claim Reimbursement and click the Confirm button.

Frequently Asked Questions

How much may I contribute to my accounts?

Healthcare FSA contribution limits are set by your employer. Contact your Human Resources department for more information.

For a dependent care FSA, you may contribute up to \$5,000 per family, per plan year for single employees and married employees filing joint tax returns (\$2,500 if married and filing separate tax returns), according to IRS regulations.

Where can I find my account balance and review the status of my claims?

Account balance and claims status information is available any time on the Personal Funding Account page at premera.com.

How can I access my funds?

Use your healthcare payment card to access your FSA funds. You can also pay for eligible expenses with another form of payment and request reimbursement from your account.

Dependent care FSA funds may only be accessed by paying out of pocket and requesting reimbursement.

How will I receive my reimbursements?

You are eligible to receive funds by check or direct deposit. For quicker reimbursements, sign up for direct deposit from your online account. Reimbursement checks will be issued by ConnectYourCare, an independent company responsible for administering claim reimbursements for Premera.

Is the healthcare payment card a debit card?

No, your healthcare payment card is a prepaid card. It is provided to give you quick access to the funds in your account. Some merchants may require a personal identification number, or PIN, to use this card. To request a PIN, call 888-999-0121. To use this card without a PIN, select "credit" at the payment terminal.

What happens if I use my account for a non-eligible expense?

When filing a manual request for reimbursement, the request will be denied. If you use your healthcare payment card and the expense is deemed ineligible, you will be required to reimburse your account for that transaction.

Do I need to keep my receipts when I use my card?

YES! We may request documentation any time you use your payment card. Therefore, always save your receipts. Receipts must contain the following information:

- Name of patient/person receiving service
- Date of service
- Name and address of service provider/merchant
- Description of the expense or service provided
- Amount charged

Non-itemized cash register tapes, credit card receipts and cancelled checks alone do not provide proper substantiation.

Where can I use my healthcare payment card?

Your healthcare payment card can be used nationwide at qualified merchants. Examples of qualified merchants may include pharmacies, doctors' offices, vision centers, and hospitals. Your card should only be used to pay for medical expenses eligible under your plan, and you should always save your receipts. Visit premera.com/merchants for a current list of qualified merchants.

What if I don't submit my receipts?

You must provide the receipts within the time requested, or the transaction will be deemed ineligible, and you will be required to refund the amount. If you fail to submit required receipts within 45 days, your payment card will be deactivated. If you fail to reimburse the account, the amount may be added to your W-2 or withheld from your pay.

Can I order a replacement or additional card for my spouse or dependent?

Yes. There is a small fee for an additional or replacement card. Simply log in to your online account or contact Customer Service to request an additional card.
