Health Savings Account

You enrolled in a Health Savings Account (HSA). Now what?

How does an HSA work?

- **Accessing Funds.** When you have an eligible medical expense, you can pay for it with your healthcare payment card, or pay out of pocket and request reimbursement online by logging in to your account and selecting Claims from Insurance Plan under Payments & Reimbursements.
- **Direct Deposit.** Reimbursement is made by check or direct deposit. If you want to choose the fastest way to receive your funds, you should sign in to your account and select “Bank Accounts” under “Settings and Preferences” to add your direct deposit information.
- **Manage Claims.** If your employer chose to provide you with the option for streamlined claims in addition to the payment card, you will be able to manage your claims online by selecting the ones you want to have paid from your HSA.

What happens if I use the account for a non-eligible expense?

If you use the account for a non-eligible expense, the funds used for that expense will be taxed since their initial contribution to the account was tax-free. In addition, if you are under the age of 65, you will also be subject to an additional tax penalty.

Can I use my HSA to pay for medical expenses incurred before I set up my account?

No, you cannot reimburse medical expenses that were incurred before your account was established.



**What happens if I become eligible to contribute to an HSA mid-year?
What is my maximum contribution?**

You can make a full year's contribution, even if you become eligible mid-year; however, you need to remain HSA-eligible through the last month of the following calendar year to avoid tax and penalty.

Can I make changes to the amount I contribute to my HSA account during the plan year?

You can change the amount you contribute to your HSA at any time during the plan year. If you are changing the amount you contribute through payroll on a pre-tax basis, you will need to check with your employer.

You can also make changes to contributions made outside of payroll on the HSA page in your online account.

Choose the "What Would You Like To Do" drop-down and choose "Manage HSA Contributions," then "Add/Change Contributions." This option lets you make contributions on a recurring basis or one-time only.

[Note: Contributions made online outside of payroll are post-tax and can be deducted at tax time.](#)

What investment options will I have with my HSA?

With your HSA, you have access to a fully integrated investment center, with an annual fee that provides unlimited investment trading. You can also use the auto invest feature, to quickly and easily set up automatic transfers of your HSA funds into your investment portfolio.

What information is reported to the IRS?

The HSA custodian or trustee is required to report the total contributions made to your HSA each year (reported on Form 5498), as well as the total amount of funds taken from the account (reported on Form 1099-SA). The forms are sent to you as the account holder and to the IRS.

What happens to the money in my HSA if I no longer have coverage under a Qualified High Deductible Health Plan (QHDHP)?

Once funds are deposited into the HSA, they can be used to pay for qualified medical expenses tax-free, even if you no longer have a QHDHP. The funds in your account remain in the account until you use them, and there is no time limit on use.

If you are no longer eligible for an HSA, you can no longer make contributions to the account, but you continue to own it.

What happens to the money in my HSA after I turn age 65?

You can continue to use your account tax-free for out-of-pocket health expenses. When you enroll in Medicare, you can use your account to pay Medicare premiums, deductibles, co-pays, and coinsurance under any part of Medicare. If you have retiree health benefits through your former employer, you can also use your account to pay for your share of retiree medical insurance premiums. You cannot use your account to purchase a Medicare supplemental insurance or "Medigap" policy.



Can I borrow against my HSA?

No, you cannot borrow against or pledge funds in your HSA.

What happens to my HSA when I pass away?

If you are legally married at the time of your death, your spouse becomes the owner of the HSA when you die, unless you have specified a different beneficiary. If you are not married at the time of your death, the HSA balance becomes part of your taxable estate.
