Local rules: We've updated the local rules Premera Blue Cross Medicare Advantage uses effective June 2, 2020. You can find the update by following the instructions listed above and clicking on [Premera Local Rules](#) at the top of the page.

Durable Medical Equipment (DME): As a reminder, all DME over \$500 requires prior authorization and is subject to clinical review for medical necessity even if it isn't listed on the prior authorization list.

PREFERRED BIOSIMILARS FOR PREMIERA MEDICARE ADVANTAGE PLANS EFFECTIVE JUNE 2, 2020.

Herceptin (trastuzumab) Biosimilars

Trazimera™ (trastuzumab-qyyp), a biosimilar to Herceptin® (trastuzumab), will be preferred biosimilar for the treatment of HER2-positive breast cancer, HER2-positive metastatic gastric cancer, and HER2-positive gastroesophageal junction adenocarcinoma. The biosimilars Herzuma® (trastuzumab-pkrb), Kanjinti™ (trastuzumab-anns), Ogivri™ (trastuzumab-dkst) and Ontruzant® (trastuzumab-dttb) are non-preferred biosimilars and require inadequate response or intolerance to Herceptin® or Trazimera™. In addition, the non-preferred biosimilars will require prior authorization.

Rituxan (rituximab) Biosimilars

Ruxience™ (rituximab-pvvr), a biosimilar to Rituxan® (rituximab), will be preferred biosimilar. Truxima® (rituximab-abbs) is a non-preferred biosimilar and requires an inadequate response or intolerance to Rituxan® or Ruxience™. In addition, the non-preferred biosimilar will require prior authorization.

Avastin (bevacizumab) Biosimilars

Zirabev™ (bevacizumab-bvzr), a biosimilar to Avastin® (bevacizumab), will be preferred biosimilar. Mvasi™ (bevacizumab-awwb) is a non-preferred biosimilar and requires an inadequate response or intolerance to Avastin® (bevacizumab) or Zirabev™ (bevacizumab-bvzr). In addition, the non-preferred biosimilar will require prior authorization.
