PREFERRED HYALURONIC ACID (HA) PRODUCTS EFFECTIVE OCTOBER 20, 2020.

To address the high cost of drugs and provide the best value for our members and providers, we're making changes to hyaluronic acid (HA) coverage under the medical benefit.

There are currently 16 FDA-approved HA products on the market today. To date, no study has shown one HA product to be superior to another.

The following HA products will be preferred and will not require prior authorization:

PREFERRED BOTULINUM TOXIN PRODUCTS EFFECTIVE OCTOBER 20, 2020

Xeomin® (incobotulinumtoxinA) will be preferred botulinum toxin product.

Botox® (onabotulinumtoxinA), Dysport® (abobotulinumtoxinA) and Myobloc® (rimabotulinumtoxinB) will be considered non-preferred and require inadequate response or intolerance to Xeomin® (incobotulinumtoxinA) for all indications except chronic migraine.

All products will continue to require prior authorization.
