### PART B DRUGS PRIOR AUTHORIZATION

Effective October 1, 2022, the following part B drug HCPCS code updates were in effect:

Effective January 1, 2023, the following part B drug will require prior authorization:

**Rituximab products**

Starting February 1, 2023, as a part of step therapy requirement, use the preferred products Rituxan®, Ruxience®, or Truxima first, which don't require prior authorization.

**Trastuzumab products**

Starting February 1, 2023, as a part of step therapy requirement, use the preferred products Herceptin®, Trazimera™, or Ogivri™ first, which don't require prior authorization.
