## High Deductible Plan F (HDF)

### Rates effective April 1, 2024

We can only change your subscription charges if we change them for all plans like yours in this state.

You will see that you get a discount of \$5 per month if you enroll in our Automatic Funds Transfer (AFT) program. If you choose this option, you will no longer send us a check each month. Instead, one month's subscription charges will be withdrawn from your bank account automatically each month.

Starting June 1, 2024, you may be eligible for a discount on your premium if you qualify for our spousal discount. Eligibility requires both beneficiaries to be enrolled on a standard Premera Blue Cross Medicare Supplement plan (effective 2010 and later) and live at the same mailing address. You also must be married or a state-registered domestic partner. You can request the discount by visiting [ms.premera.com](https://www.ms.premera.com), then select Coverage and Benefits.
