<u>Credentialing Clarifications and Exceptions</u>

Important Note: If a practitioner's individual name is listed in a directory they <u>must be</u> credentialed.

<u>Master Level Therapist (MLT</u>): includes Licensed/Certified **Social Workers**; Licensed **Family/Marriage Therapists**; and Licensed **Professional Counselors**.

<u>Behavioral health practitioners:</u> includes Psychiatrists and other physicians, Addiction medicine specialists, Doctoral or master's-level psychologists, Master's-level clinical workers, Master's-level clinical nurse specialists or psychiatric nurse practitioners and other behavioral healthcare specialists.

<u>Nurse Practitioner:</u> Credentialing required if practice is independent or practices as a PCP. (PCP specialties are Family Practice, Pediatrics, General Internists, General Practice, and Pediatric, Adult, and Family Nurse Practitioners.)

Nurse Practitioner – Midwifery or OBG specialty: Credentialing required.

<u>Physician Assistant:</u> Credentialing required if contracted with Blue Cross Blue Shield of Alaska. Credentialing required if PCP and listed in a directory. Credentialing required if group or individual requests being listed in a directory.

<u>Certified Registered Nurse Anesthetist, Registered Nurse First Assist:</u> Credentialing required if group or individual requests being listed in a directory.

<u>Midwives:</u> Credentialing required for all Midwives regardless of whether their practice is dependent or independent. Credentialing is <u>not</u> required for Midwives who only provide GYN services and are under the auspices of a physician.

<u>Hospital/Facility Based:</u> Not credentialed if practice is inpatient within a hospital/facility-based setting.

(Includes Pathologist, Radiologist, Anesthesiologist, Emergency Room Physician, Hospitalist, Urgent Care, Neonatologist, Surgical Assistant, etc.)

Board Certification: Board certification will be verified if disclosed on the credentialing or recredentialing application.

<u>DEA/DEA Coverage Plan:</u> Verified when received. Must be for the state or states in which the practitioner is providing services to members.
