

# Childhood Immunization Status (CIS)

## APPLICABLE LINES OF BUSINESS

- Commercial
- Exchange

## MEASURE DESCRIPTION

Percentage of children who turn two years of age during the measurement year and who received the following vaccinations on or before their second birthday<sup>i</sup>:

Childhood Immunizations – Combo 10*
4 Diphtheria, Tetanus-acellular Pertussis (DTaP)
3 Polio (IPV)
1 Measles, Mumps and Rubella (MMR)
3 Haemophilus Influenza Type B (HiB)
3 Hepatitis B (HepB)
1 Varicella Zoster Vaccine (VZV) or history of varicella zoster (e.g., chicken pox)
4 Pneumococcal Conjugate Vaccine (PCV)
1 Hepatitis A (HepA)
2 Influenza (Flu) At least 2 influenza vaccines with different dates of service. 1 of the 2 vaccinations can be a Live Attenuated Influenza Vaccine (LAIV) administered on the child's second birthday.
2 or 3 Rotavirus (RV) At least 1 dose of the 2-dose vaccine <b>and</b> at least 2 doses of the 3-dose vaccine on different dates of service <b>or</b> at least 2 doses of the 2-dose vaccine on different dates of service <b>or</b> at least 3 doses of the 3-dose vaccine on different dates of service.

\*Commercial reports Combination 3, Combination 7, and Combination 1, and Exchange reports Combination 3 and Combination 10.

## EXCLUSIONS

Patients are excluded if they:

- Had an anaphylactic reaction/contraindication to one or more of the vaccines. In this case document the date, vaccine, and type of reaction.
- Use hospice services during the measurement year.
- Died any time during the measurement year.

## MEDICAL RECORDS

Patient medical records should include:

- For immunization evidence obtained from the medical record, evidence that the antigen was rendered from one of the following:

- A note indicating the name of the specific vaccine and the date it was administered.
- A certificate of immunization prepared by an authorized health care provider or agency including the specific dates and types of immunizations administered.
- For history of illness or a seropositive test result, a note indicating the date of the event, which must have occurred by the member's second birthday.
- Notes in the medical record indicating that the member received the immunization "at delivery" or "in the hospital" may be counted only for immunizations that do not have minimum age restrictions (e.g. before 42 days after birth). This is common with the first administration of the Hep B vaccine.

## TIPS FOR SUCCESS

### Patient Care

- Review the CDC timeline of recommended childhood immunizations with parents<sup>v</sup>.
- Upload immunizations to the applicable Washington or Alaska Immunization Registry.
- Administer vaccinations during already scheduled appointments.
- At each appointment, review immunization records and encourage the opportunity to catch up on missing immunizations.
- Advise parents on the importance of completing each vaccine series.

### Documentation and Coding

- Review and document the child's vaccinations with the name of the specific antigen and the date it was administered.
- Review and document the child's history and date of illness such as chicken pox, measles, etc.
- Partner with your health plan payers to submit electronic data from your EMR.
- Document medical and surgical history in the medical record with dates in structured fields so your EMR can include these in reporting. This will allow the corresponding code to be included in electronic reporting, including claims, to health plans.
- Code for exclusions.
- NCQA has transitioned this measure to an Electronic Clinical Data Systems (ECDS) reported measure. This means that health plans can only use information submitted *during* the measurement year to qualify for this measure. Information can be submitted electronically (e.g., EMR extracts and FHIR feeds), via claims codes, and in medical record documentation sent to the plan. Plans will no longer perform chart reviews *after* the measurement year for this measure.
