

# Child and Adolescent Well-Care Visits (WCV)

This measure is a new measure in which National Committee for Quality Assurance (NCQA) combined the Well-Child Visits in the 3rd, 4th, 5th, and 6th Years of Life (W34) with the Adolescent Well-Care Visits (AWC) measure.

The Bright Futures/American Academy of Pediatrics (AAP) developed a set of comprehensive health guidelines for well-childcare, known as the "periodicity schedule." It is a schedule of screenings and assessments recommended at each well-child visit from infancy through adolescence.<sup>1</sup>

Regular checkups are an important way to keep track of a child's health and physical, emotional, and social development. These visits are important for all children, including children and youth with special health care needs who may also be under the care of specialists. Your conversations can range from sharing successes and milestones, to overall concerns about child development, to challenges in daily routines. Think of these visits as a chance to help parents and guardians learn as much as they can about the best ways to help their child grow. By focusing on growth and learning, parents and guardians you and providers can make sure a child is developing as expected. The family and provider form a partnership based on respect, trust, honest communication, and understanding the family's culture and traditions.<sup>ii</sup>
