PROGRAM DESCRIPTION AND RESPONSIBILITIES

The Premera Blue Cross Member Advisory Council (MAC) is established to include the perspectives of members and their advocates in topics and materials specific to Premera processes, programs, and plan design. The goal of MAC is to serve our members effectively, efficiently, and with excellence.

MAC Member Criteria

MAC members must:

- Be an actively enrolled Premera Medicare Advantage member, or be a family member, legal guardian, or caretaker of an actively enrolled Premera Medicare Advantage member.
- Reside in the region where the meetings take place.
- Agree to serve on the MAC for two (2) years unless enrollment changes.
- Be willing to have their name listed as a MAC member in Premera internal resources and publicly in Premera materials such as newsletters or web pages.

Additionally, Premera MAC member selection shall include a diversity of opinions and experience, and a balance of cultural, racial, age, and gender representation. Each region will select 5–10 MAC members.

MAC Member Responsibilities

- Be enthusiastic about MAC participation and have a genuine interest in improving the Premera member experience.
- Communicate well and provide constructive points of view and insights.
- Attend and participate in at least three out of four meetings each year. If meeting attendance is not possible, member will inform the coordinator in advance.
- Review materials provided in advance of meetings, if applicable.
- Treat each other with dignity and respect, which includes avoiding statements or assumptions based on race, ethnicity, gender, sexual orientation, gender identity, age, disability, or any other personal characteristic.
- Maintain the confidentiality of personal information shared in meetings.
- Disclose potential conflicts of interest, real or perceived, before participating in discussions.

Meeting Structure

Meetings will take place quarterly in each region for 60–90 minutes. They will be in person if possible or virtual by video platform if circumstances indicate. Each meeting will have a specific pre-identified topic and objective and will report on the findings and actions from previous meetings. Premera departmental and organizational leaders will bring forward topics and the structure for providing feedback, which may include discussion or written insights.

Notice of Nondiscrimination
