Member questions

Why is fall prevention important?	According to the Centers for Disease Control and Prevention (CDC), more than one out of four adults aged 65 and older fall each year. Fall prevention is important because falls can lead to injuries that disrupt activities of daily living.
What makes me more likely to fall?	There are multiple conditions that contribute to falling. These risk factors include history of falls, muscle weakness, balance or walking problems, vision problems, use of certain medicines, and environmental hazards.

How can my doctor help me prevent falls?

Your doctor can evaluate your risk for falling and create a plan to help prevent future falls, especially if you have experienced a fall, near fall, or problems with walking and balance.

Questions to ask your doctor:

- Which of my medications might increase my risk of falling?
- Are there assistive devices that would be appropriate for me to reduce my risk of falling?
- What types of balance or strength building exercises would be appropriate for me?
