<b>Title</b>	<b>Modifier 47 – Anesthesia by Surgeon</b>

Coverage of any service is determined by a member's eligibility, benefit limits for the service or services rendered and the application of the Plan's Medical Policy. Final payment is subject to the application of claims adjudication edits common to the industry and the Plan's **professional or facility services claims coding policies**. Reimbursement is restricted to the provider's scope of practice as well as the fee schedule applicable to that provider.

<b>Purpose</b>	To define when the Plan recognizes services appended with Modifier 47 when submitted on a professional claim.
<b>Scope</b>	Applies to all Premera Blue Cross, Premera Blue Cross Blue Shield of Alaska, LifeWise Health Plan of Washington, LifeWise Assurance Company and Premera Blue Cross HMO lines of business and products.
<b>Policy</b>	<p>The Plan recognizes Modifier 47- <i>Anesthesia by Surgeon</i> when appended to a surgical service to indicate regional or general anesthesia <b>was provided by the attending or assistant surgeon in addition to performing the surgical service.</b></p> <p>Modifier 47 is <b>not appropriate</b> in the following situations/examples:</p> <ul style="list-style-type: none"> <li>appended to an anesthesiology code (CPT codes 00100-01999)</li> <li>used to represent a local anesthesia service</li> <li>submitted by an Anesthesiologist on any anesthesia codes</li> <li>appended to any surgical service code when the surgeon renders <b>moderate sedation</b> rather than regional or general anesthesia</li> </ul> <p>Modifier 47 is appended only to the surgical procedure code when the surgeon performing the surgery <b>also</b> renders general or regional anesthesia.</p> <p>No additional reimbursement will be available for the anesthesia as it is considered inclusive with the surgery.</p>
<b>Violations of Policy</b>	Violations of this policy by any party that enters into a written arrangement with the Plan may result in increased auditing and monitoring, performance guarantee contractual penalties and/or termination of the contract. Disciplinary actions will be determined by the plan.
<b>Exceptions</b>	Exceptions to the policy may be made where a provider or employer group contract dictates otherwise.
