Coverage of any service is determined by a member's eligibility, benefit limits for the service or services rendered and the application of the Plan's Medical Policy. Final payment is subject to the application of claims adjudication edits common to the industry and the **Plan's professional or facility services claims coding policies**. Reimbursement is restricted to the provider's scope of practice as well as the fee schedule applicable to that provider.

<b>Purpose</b>	To define when the Plan recognizes services appended with modifier 54, 55, or 56 that are submitted on a professional claim.
<b>Scope</b>	Applies to all Premera Blue Cross, Premera Blue Cross Blue Shield of Alaska, LifeWise Health Plan of Washington, LifeWise Assurance Company, and Premera Blue Cross HMO lines of business and products.
<b>Policy</b>	<p>The Plan recognizes modifiers 54, 55, &amp; 56 appended to a service to indicate when a physician or other qualified healthcare professional furnishes <b>only part of a global surgical package</b> and relinquishes the other portion(s) of the surgical package to another physician or other qualified healthcare professional <b>belonging to a different practice</b>.</p> <p>These modifiers are applicable to codes in the current CMS National Physician Fee Schedule (<a href="#">LINK</a>) that include global periods of 10 or 90 days. These modifiers <b>do not apply</b> to assistant surgeon services:</p> <ul style="list-style-type: none"> <li>• <b><u>Modifier 54 – Surgical Care Only</u></b> <ul style="list-style-type: none"> <li>○ Used to indicate when one physician or other qualified healthcare professional performs surgical <b>care only</b> and another physician or other qualified healthcare professional performs pre-operative or post-operative care, <b>each belonging to a different practice</b>.</li> <li>○ Services rendered by emergency room providers who perform a minor or major global surgical procedure (10 and 90 days respectively) in the ER should append this modifier to their services since the member is not expected to receive postoperative care in the ER setting.</li> <li>○ Reimbursement will be <b>70%</b> of the provider's applicable Fee Schedule allowed amount.</li> </ul> </li> <li>• <b><u>Modifier 55 – Postoperative Management Only</u></b> <ul style="list-style-type: none"> <li>○ Used to indicate when one physician or other qualified healthcare professional performs the <b>post-operative management only</b> and another physician or other qualified healthcare professional performs the surgical care, <b>each belonging to a different practice</b>.</li> <li>○ Reimbursement will be <b>20%</b> of the provider's applicable Fee Schedule allowed amount.</li> </ul> </li> <li>• <b><u>Modifier 56 – Preoperative Management Only</u></b> <ul style="list-style-type: none"> <li>○ Used to indicate when one physician or other qualified healthcare professional performs <b>pre-operative management only</b> and another</li> </ul> </li> </ul>

	<p>physician or other qualified healthcare professional performs the surgical care, <b>each belonging to a different practice.</b></p> <ul style="list-style-type: none"> <li>○ Reimbursement will be <b>10%</b> of the provider’s applicable Fee Schedule allowed amount.</li> </ul> <p>Reimbursement for services appended with modifiers 54, 55, &amp; 56 will be adjusted per the percentages noted above to reflect the specific <b>component</b> of surgical care rendered.</p> <p>It is the responsibility of each of the physicians or other qualified healthcare professionals to ensure that the billings accurately reflect the <b>portion of the global services</b> the physician or other qualified healthcare professional performed. Documentation in the patient’s medical record should detail the specific services rendered for each portion of the global services.</p> <p>Any billing discrepancies should be discussed between the physicians or other qualified healthcare professionals involved in the patient care for performance of the global procedure.</p>		
<b>Violations of Policy</b>	<p>Violations of this policy by any party that enters into a written arrangement with the Plan may result in increased auditing and monitoring, performance guarantee contractual penalties and/or termination of the contract. Disciplinary actions will be appropriate to the seriousness of the violation and shall be determined at Plan’s sole discretion.</p> <p>Violations of this policy may be grounds for corrective action, up to and including termination of employment.</p>		
<b>Exceptions</b>	<p>Exceptions to the policy may be made where a provider or employer group contract dictates otherwise</p>
