<p>Coverage of any service is determined by a member’s eligibility, benefit limits for the service or services rendered and the application of the Plan’s Medical Policy. Final payment is subject to the application of claims adjudication edits common to the industry and the <b>Plan’s professional or facility services claims coding policies</b>. Reimbursement is restricted to the provider's scope of practice as well as the fee schedule applicable to that provider.</p>			
<b>Purpose</b>	To define when the Plan recognizes services appended with Modifier 73 that are submitted on a CMS 1450 paper claim or 837I electronic claim form.		
<b>Scope</b>	Applies to all Premera Blue Cross, Premera Blue Cross Blue Shield of Alaska, LifeWise Health Plan of Washington, LifeWise Assurance Company and Premera Blue Cross HMO lines of business and products.		

<p><b>Policy</b></p>	<p>The Plan recognizes Modifier 73- <i>Discontinued Outpatient Hospital/Ambulatory Surgery Center (ASC) Procedure Prior to Administration of Anesthesia</i> appended to a service to indicate that due to extenuating circumstances or those that threaten the wellbeing of the patient, a surgical or diagnostic procedure that requires anesthesia at an outpatient hospital or ambulatory surgical center (ASC) was discontinued <b>prior to</b> the administration of anesthesia, and before the surgical procedure was started. The patient must have already been wheeled into the surgical suite.</p> <p>Anesthesia includes local blocks, regional blocks, moderate sedation, deep sedation, or general anesthesia.</p> <p>Append modifier 73 to the intended surgical procedure code which represents the discontinued <b>ASC or outpatient facility service</b>. Documentation in the medical records must list why and when the physician decided to cancel the procedure, services and supplies that were/were not rendered, and the time spent preoperatively.</p> <p>Modifier 73 is only appended to a discontinued <b>ASC or outpatient facility service prior to</b> the administration of anesthesia and <b>before</b> the surgical procedure started when billed on a facility claim.</p> <p>Modifier 73 must not be appended in conjunction with the following:</p> <ul style="list-style-type: none"> <li>• <b>any</b> ASC or outpatient facility procedure that was electively discontinued by the patient or physician.</li> <li>• unlisted procedure codes</li> <li>• add-on procedure codes</li> <li>• professional services, or</li> <li>• after the administration of anesthesia</li> </ul> <p>Modifier 53-<i>Discontinued Procedure</i> should not be appended for any discontinued ASC or outpatient facility service since modifier 53 is appended to professional services only.</p> <p>Modifier 74- <i>Discontinued Outpatient Hospital/Ambulatory Surgery Center (ASC) Procedure After Administration of Anesthesia</i> is only appended to a discontinued ASC or outpatient facility service <b>after</b> the administration of anesthesia or after the procedure was started (incision made, intubation started, etc.) billed on a facility claim.</p> <p>Reimbursement for services appended with Modifier 73 will be adjusted to 50% of the applicable Fee Schedule allowed amount.</p>
