Purpose	To define how the Plan limits prolonged services codes when separately billed for labor management that are submitted on a CMS 1500 paper claim or 837P electronic claim form.				
Scope	Applies to all Premera Blue Cross, Premera Blue Cross Blue Shield of Alaska, LifeWise Health Plan of Washington, LifeWise Assurance Company, and Premera Blue Cross HMO lines of business and products				
Policy	The Plan restricts the use of prolonged service procedure codes when they are billed separately or with an Evaluation and Management (E/M) code to represent labor management as identified by the diagnosis, by a provider who does not perform the actual delivery.				
	The Plan will not separately reimburse billed prolonged services for professional outpatient services or for inpatient services, when billed with an E/M code, to represent labor management when that provider does not deliver the baby.				
	Management of labor is considered a component of the maternity care delivery codes and is not separately billable.				
Codes/Coding Guidelines	Prolonged services procedure codes for both outpatient and inpatient care and coding guidelines from CPT Codebook include the following:				
	 +99415 – Prolonged clinical staff services (the service beyond the highest time in the range of total time of the service) during and evaluation and management service in the office or outpatient setting, direct patient contact with physician supervision; first hour (list separately in addition to code for outpatient Evaluation and Management service) Use 99415 in conjunction with 99202, 99203, 99204, 99205, 99212, 99213, 99214, 99215. Do not submit with 99417. 				
	 +99416 - Prolonged clinical staff services (the service beyond the highest time in the range of total time of the service) during and evaluation and management service in the office or outpatient setting, direct patient contact with physician supervision; each additional 30 minutes (list separately in addition to code for outpatient Evaluation and Management service) Use 99416 in conjunction with 99415. Do not submit with 99417 				
	+99417 - Prolonged outpatient evaluation and management service(s) time with or without direct patient contact beyond the required time of the primary service when				

the primary service level has been selected using total time, each 15 minutes of total time (List separately in addition to the code of the outpatient Evaluation and Management service)

- o Use 99417 in conjunction with 99205, 99215, 99245, 99345, 99350, 99483.
- O Use 99417 in conjunction with 99483, when the total time on the date of the encounter exceeds the typical time of 99483 by 15 minutes or more.
- o Do not use on the same date of service as 90833, 90836, 90838, 99358, 99359, 99415, 99416.
- +99418 Prolonged inpatient or observation evaluation and management service(s) time with or without direct patient contact beyond the required time of the primary service when the primary service level has been selected using total time, each 15 minutes of total time (List separately in addition to the code of the inpatient and observation Evaluation and Management service)
 - o Use 99418 in conjunction with 99223, 99233, 99236, 99255, 99306, 99310.
 - Do not report on the same date of service as 90833, 90836, 90838, 99358, 99359.
- 99358 Prolonged evaluation and management service before and/or after direct patient care; first hour
- +99359 Prolonged evaluation and management service before and/or after direct patient care; each additional 30 minutes (list separately in addition to code for prolonged service).
 - o Use in conjunction with 99358.
 - o (Do not report 99358, 99359 on the same date of service as 99202-99205, 99212-99215, 99417).
- +G2212 Prolonged office or other outpatient evaluation and management service(s) beyond the maximum required time of the primary procedure which has been selected using total time on the date of the primary service; each additional 15 minutes by the physician or qualified healthcare professional, with or without direct patient contact (list separately in addition to CPT codes 99205, 99215 for office or other outpatient evaluation and management services) (Do not report G2212 on the same date of service as 99354, 99355, 99358, 99359, 99415, 99416). (Do not report G2212 for any time unit less than 15 minutes)
- +G0316 Prolonged hospital inpatient or observation care evaluation and management service(s) beyond the total time for the primary service (when the primary service has been selected using time on the date of the primary service); each additional 15 minutes by the physician or qualified healthcare professional, with or without direct patient contact (list separately in addition to CPT codes 99223, 99233, and 99236 for hospital inpatient or observation care evaluation and management services). (Do not report G0316 on the same date of service as other prolonged services for evaluation and management 99358, 99359, 99418, 99415, 99416). (Do not report G0316 for any time unit less than 15 minutes)
- +G0318 Prolonged home or residence evaluation and management service(s) beyond the total time for the primary service (when the primary service has been selected using time on the date of the primary service); each additional 15 minutes by the physician or qualified healthcare professional, with or without direct patient contact (list separately in addition to CPT codes 99345, 99350 for home or

(Do not report G0318 for any time unit less than 15 minutes) (+ = Add-on code; bill with an appropriate primary code) Violations of this policy by any party that enters into a written arrangement with the Plan may result in increased auditing and monitoring, performance guarantee contractual penalties and/or termination of the contract. Disciplinary actions will be determined in Plan's sole discretion.
